2.1. Reason for setting up a new Competence Centre

1. Why is a Competence Centre for Innovation Procurement set up?
2. Is there a political mandate? Is there a national action plan?
3. Is the Competence Centre a top-down or a bottom-up initiative?
4. If it exists, what is the normative reference that gives the body the qualification of Competence Centre for Innovation Procurement (political mandate)?
5. What are the strategic and operational objectives and plans on a three-year and/or yearly basis?
6. What are the most critical and challenging areas to consider when implementing a new competence centre?
7. Please name the main goals for your Competence Centre this year and in five years?

2.2. Location of the new Competence Centre

8. Is there an institution pre-existing or will a new one be set up?
9. Where will the Competence Centre be located? Within a central purchasing body, ministry, innovation agency etc.?

2.3. Mission and Scope

10. What is the mission of the institution representing the Competence Centre for Innovation Procurement?
11. What is the objective scope of the Competence Centre?

2.4. Budget & employees

12. How will the Competence Centre for Innovation Procurement be financed?
13. Will there be third party funding or grants involved?
14. Will the Competence Centre have designated employees or use human resources from other institutions?
15. What should be the professional profiles and related skills of the employees of competence Centre?

2.5. Stakeholders and other partners

16. What are the stakeholders identified to cover all areas of interest?
17. Which of the stakeholders needs to be involved in the set-up of the Competence Centre?

2.6. Target group

18. Who will be your main target group at the beginning?
19. How many procurers or other stakeholders can benefit from the services of the Competence Centre? For which specific projects?

2.7. Services

20. What are the main and the minimum lines of activity, function and service? (You can consult our list of existing services for inspiration <http://procure2innovate.eu/innovationprocurement/>)
21. Will the Competence Centre provide funding or advisory on funding programmes?
22. What are your Key-Performance-Indicators to evaluate the Competence Centre?
23. In your opinion, how long will it take to achieve first results in those activities? Are there any (political) timeframes to respect?
